Please note all Honours (Life Membership) nominations must be submitted no later than 1st of February and August 1st 2016.

Any submissions made after these dates will not be accepted.

These awards are orientated towards involvement and activities during the 2015/16 season calendar year. The most important area for selection is the individual's/club's contribution from the 1st July 2015 – 30th June 2016.

Organisation Employees:

Paid service will only be counted if you are applying for the Lifeguard of the Year Award. All other awards recognise voluntary contributions only.

GUIDELINES FOR SUBMISSION

1. Applicants are required to complete and **submit a nomination form**.
 - This nomination form can be found in section three of this circular.
2. Applicants must **address the selection criteria** for their individual nominated award.
 - Selection criteria for each award can be found in section two of this circular.
 - Please list each selection criteria as a heading with your response typed under each section.
 - Please complete using Arial font and minimum 10 point size.
 - Please no hand written submissions (Inclusive of all attachments and additional information)

Note: If you are unable to access the PDF file please request a Microsoft Word version
3. Applicants are to include a digital profile image of themselves for the individual awards or logo for 'Club of the Year' and 'Community Education Program of the Year' via email or on a USB (JPEG & minimum 2MB in size). **Please ensure all photographs are from the shoulders up.**
4. Complete nominations are to be **sent to respective Branch or State/Territory center** by the closing date specified by them.

When completing the selection criteria, applicants must also address the following

1. **2015-16 Contribution**
This is the **single most important area of assessment** and the judges will rely heavily on information placed on your nomination form, selection criteria and endorsements by the **club/branch/state**.
2. **Past Contribution**
The judges are looking for growing commitment to surf lifesaving, impact of involvement and activities, and continuous improvement while showing initiative, motivation and leadership. This involvement will span the past three years unless the activity is of particular importance.
3. **Future Contribution**
Applicants will identify future commitments and ambitions to surf lifesaving.



SELECTION PROCESS

1. Upon receipt of completed nominations, State/Territory center will consider all nominations and determine a State/Territory 'winner'.
2. State/Territory winners will be forwarded onto SLSA as finalists for consideration for the national award.
3. All finalist for the national award will go through a selection panel which will involve a review of applications and in some cases an interview.

PRESENTATION OF AWARDS

The SLSA National Awards of Excellence will be held on **Saturday 22nd October 2016 in Sydney (venue TBC)**.

In recognition of their achievements all national finalists will be recognised at the National Awards of Excellence and are encouraged to attend.

SECTION 2 – SPECIFIC AWARD CRITERIA AND CONDITIONS

1. Meritorious Awards

Meritorious Awards are awarded to affiliated clubs and/or their members and/or the public for outstanding deeds of bravery performed during lifesaving operations of SLSA (during and outside of designated patrol hours).

Essential Criteria:

The following documents are required with each nomination:

1. The application for Meritorious Award form (Full nomination forms provided in the following pages - please ensure no hand written submissions). Please attach all additional information if the provided space within the forms is not sufficient
2. The SLSA Incident Report Form, copy of the incident report log and copy of the patrol log (where applicable)
3. Other supporting statements – police, ambulance and/or witness statements
4. Information or reports of rescues are also welcome from media agencies

Selection Criteria – *please answer the selection criteria under the following headings for the period of 1st July 2015 to 30th June 2016 unless stated otherwise.*

Awards are established as follows:-

1. **Meritorious Awards - Individual**

a. **Silver Medallion**

Very high level of risk to rescuer combined with optimal application of skills and supporting systems.
Outcome for patient/s without rescue attempt = Definite fatality

b. **Bronze Medallion**

High level of risk to rescuer combined with very good application of skills and supporting systems.
Outcome for patient/s without rescue attempt = High chance of a fatality

c. **Certificate of Merit**

Moderate level of risk to rescuer combined with good application of skills and supporting systems.
Outcome for patient/s without rescue attempt = Serious injury / possibility of a fatality

2. **Meritorious Awards – Group or Club**

- a. Certificate of Merit with Silver Medallion inset
- b. Certificate of Merit with Bronze Medallion inset
- c. Certificate of Merit

The group or club award is issued for rescues of exceptional merit, in which a group of members are involved and where no individuals can be singled out for an award.

3. **Commendation**

Commendations recognise outstanding team work, rescue skills, rescue management, individual displays of initiative and resourcefulness, and well conducted rescue activity (e.g. first aid, resuscitation, IRB rescues, board and tube rescues etc.) by members of Surf Life Saving Australia. This recognition award includes rescues or application of lifesaving skills by club members in exceptional circumstances on or off the beach, e.g. resuscitation of a person struck by lightning.

This award is presented to lifesavers involved in exceptional rescues. After consideration, a Commendation may be awarded to an individual or group, club or service.

Note: Rescues can occur at any time - on and off duty and at any location.

2. Hall of Fame Awards

The Surf Life Saving Australia (SLSA) Hall of Fame is an integral part of recognising the achievements and efforts of members in the Surf Life Saving movement. The Hall of Fame permanently displays, commemorates and recognises members and teams who have achieved outstanding accomplishments and exceptional contributions to the development of surf lifesaving in Australia.

Selection Criteria -

Each award is allocated under the following categories:

1. Surf Lifesaving
2. Surf Lifesaving – Administration
3. Surf Lifesaving – Sport

Surf Lifesaving

This category recognises those who have been involved in all facets of surf lifesaving operations. Examples are active patrolling, training and examination, rescue services and the general support activities involved in beach patrols, search and rescue, and surveillance.

Surf Lifesaving - Administration

This category recognises those involved in the purely administrative aspects of surf lifesaving. Examples are, but not limited to, club secretaries and treasurers. This category also includes surf sports officials.

Surf Lifesaving - Sport

This category recognises those who have excelled in lifesaving sports and/or the coaching and training associated with lifesaving sports.

Essential criteria - *please supply evidence, where appropriate, via either a printout from Surfguard or equivalent*

1. Please attach additional information if space is not sufficient
2. All nomination forms should be accompanied by the following supporting materials:
 - A photograph of the nominee and,
 - A conclusive history of the nominee (maximum of 2 pages)
3. Displayed exceptional service to surf lifesaving in the specific category
4. Achieved outstanding individual or team accomplishments which sets the individual or team apart from other surf lifesavers or teams
5. Displayed sustained excellence over a long period of time to the category for which they are nominated.
6. Endorsement by the respective Branch and/or State center

Only current or past individual members of SLSA are eligible for induction into the Surf Life Saving Australia Hall of Fame (Note: that nominations may be for eligible individual members or for teams of eligible members). Nominations not endorsed may only be re-submitted for consideration after a period of two (2) years. Nominations being resubmitted should be enhanced in order to meet the standard of the award.

Nominations may only be for one category, however, evidence supporting the nomination covering activities relevant to the other categories should be provided and will be taken into consideration. It is important that the complete career of the nominee is put forward to allow a total assessment. Nominees are to be in good standing with SLSA.

3. Honours Awards (SLSA Life Membership only)

Surf Life Saving Australia's (SLSA) Honours System recognises those individual members who have committed years of service to the organisation. This recognition system is designed to follow a similar structure to the Australian Honours Framework.

Selection Criteria - *please supply evidence where appropriate, via either a printout from Surfguard or equivalent*

Life Membership Award – Members must have rendered distinguished voluntary service to SLSA that is both sustained and conspicuous in contribution. The distinguished nature of this service needs to evidence both sustained service and conspicuous contribution to SLSA by identifying the nominee's contribution towards the development of surf lifesaving in Australia.

1. Candidates are to be nominated using the appropriate form by the President or two (2) members of SLSA
2. Upon confirmation, nominations by the Club/Branch are to be forwarded to the relevant State/Territory centers
3. State centers shall confirm the details provided. It is the responsibility of the Appointed Director to submit the nomination to SLSA
4. For a member to be eligible for an SLSA Honour, the nominee must have at least 20 years of service to the organisation

Essential Criteria

1. The nomination must establish and present the case for the level of award envisioned by the proposer and seconder
2. The proposer is to summarise the nominee's personal achievements that have impacted on SLSA and/or surf lifesaving in Australia
3. It is important that the nomination is specific to the nature of the individual's achievements apart from that of a group
4. The nomination should provide substantive evidence to support the nomination
5. Authoritative sources should be used to validate accounts

Judging Process

1. The SLSA Honours Committee will review all nominations.
2. The Committee will provide a recommendation to the SLSA Board as to the appropriate Honour to be awarded to the nominee
3. The final level of award will be determined by the SLSA Board and the decision will be final
4. Any member awarded an SLSA Honour will be recorded in the minutes of the relevant Board meeting
5. Formal acknowledgement of recipients of SLSA Honours will be announced by the SLSA President
6. Unsuccessful Nominations may be re-nominated for consideration after two years

NOTE – A list of roles that an individual has held is insufficient in demonstrating the significance of that individual's service. SLSA may return a nomination to the proposer for further details if it feels that a lack of detail may be prejudicial for the nominee.

4. Surf Lifesaver of the Year

This award recognises and rewards members who have made an outstanding contribution to the delivery and development of surf lifesaving frontline services. It is aimed at active surf lifesavers undertaking lifesaving duties and who can be presented as an identifiable ambassador for surf lifesaving.

Essential Criteria – *please supply evidence, where appropriate, via either a printout from Surfguard or equivalent*

1. Current financial member of Surf Life Saving Australia
2. Surf Life Saving Australia awards/certificates held
3. Community awards/certificates held
4. Patrolling hours (rostered and achieved) for 2015/16, 2014/15 and 2013/14 seasons.

Selection Criteria – *please answer the selection criteria under the following headings for the period of 1st July 2015 to 30th June 2016 unless stated otherwise.*

1. Describe your contribution to surf lifesaving patrol duties
2. Describe how you have demonstrated commitment to public safety
3. Describe major achievements and positions, relevant to lifesaving, held at Club, Branch, State /Territory & National level
4. Describe future lifesaving ambitions in the areas of Club, Branch, State/Territory ,National and the community
5. Describe current and possible future challenges in active surf lifesaving duties and how they could possibly be overcome
6. Describe major achievements to surf lifesaving patrol duties for the two years prior to the 2015/16 season
7. What would it mean to you to be Lifesaver of the Year?
8. Any relevant additional information

An interview will be conducted with each national finalists, providing each with an opportunity to share their personal experience relating to Surf Life Saving and the organisation but not limited to areas such as:

- Patrolling duties
- Club/branch/state activities related to lifesaving services
- Rescue related activities
- Personal award development
- Community involvement in lifesaving related activities (e.g. surf education)
- Activities specific to the further enhancement and development of surf lifesaving services

Please note there are to be no aides used during the interview, this includes any hand written or typed notes, palm cards, props etc. All finalists will be provided with the opportunity to review each of the set questions 10 minutes prior to their interview.



5. Volunteer of the Year

This award will recognise an individual's contribution that has enhanced the development of surf lifesaving throughout the past year. The demonstrated achievements may be in a range of different areas of a club or surf lifesaving service organisation, or who has shown significant and outstanding achievements in one particular area.

A nominee may be a volunteer in any area of surf lifesaving including but not limited to:

- Club activities
- Carnivals
- Coaching
- Administrating
- Junior activities
- Branch/State/National activities
- Training/assessing
- Scrutineering
- Active patrolling
- Officiating

Note: Applications that focus on significant achievements in one particular area will not be considered if this area is also covered by other awards (e.g. Lifesaver, Coach, Official, Trainer and Assessor of the Year).

Essential Criteria – *please supply evidence, where appropriate, via either a printout from Surfguard or equivalent*

1. Current financial member of Surf Life Saving Australia
2. Surf Life Saving Australia awards/certificates held (where applicable)
3. Community awards/certificates held (where applicable)

Selection Criteria – *please answer the selection criteria under the following headings for the period of 1st July 2015 to 30th June 2016 unless stated otherwise.*

1. Describe your contribution to surf lifesaving, at any level in one or more areas of the organisation
2. Describe how you have demonstrated commitment to surf lifesaving across the organisation
3. Describe your major achievements and positions, held at Club, Branch, State/Territory & National level
4. Describe your future ambitions in the areas of Club, Branch, State/Territory, National and in the community
5. Describe current and possible future challenges in surf lifesaving and how they could possibly be overcome
6. Describe major achievements for surf lifesaving in the 2 years prior to the 2015/16 season
7. What would it mean to you to be Volunteer of the Year?
8. Any relevant additional information

An interview will be conducted with each national finalists to share their personal experience relating to Surf Life Saving Australia and the organisation. All finalists will be provided with the opportunity to review each of the set questions 10 minutes prior to their interview. Additionally finalist are required to prepare a 3 minute presentation at the end of the interview on a topic of their choice from the following (without any aides – includes notes, props, palm cards etc.):

- Administration
- Sponsorship
- Government/community support
- Leadership skills
- Planning your club's future
- Recruitment
- Volunteer management



6. Club of the Year

The purpose of the SLSA Club of the Year is to encourage and recognise outstanding achievements in club development that results in SLSA clubs providing safer beach and aquatic environments for the community. SLSA acknowledges that clubs achieve many outstanding achievements through their members during each season, and that many of these initiatives are inspirational and different to our core business. The process to select the Club of the Year relies on two major elements that provides the critical information for the selection panel.

The Nomination:

Finalists will be required to submit a nomination form providing essential information and addressing all of the selection criteria. The nomination **should not exceed 20 pages in length** and should be constructed in a concise well written manner that uses facts and figures to demonstrate achievements against the criteria in the nomination form and improvement in the clubs operations, benefits to the community, benefits to members, any major achievements and innovation.

Essential Information

1. Evidence that the club is a current affiliated club of Surf Life Saving Australia
2. Australian Business Number
3. Contact details for the member who is submitting the nominations
4. A copy of the clubs strategic and/or operational business plan

Selection Criteria – *please answer the selection criteria under the following headings for the period of 1st July 2015 to 30th June 2016 unless stated otherwise*

1. Clubs will demonstrate how they have accessed and implemented a continuous improvement program such as (the ASC Club Development Resources, State Department of Sport and Recreation club improvement program, an SLS improvement program or another identified improvement program) and demonstrate how that program has delivered strategic direction for the club.
2. Clubs will further demonstrate how their implemented continuous improvement program has delivered a range of sustainability measures in a minimum of two of the areas of: Governance, Leadership, Development, Engagement, and delivery of core business.
3. Clubs will evidence achievements that support SLS 2020
4. Clubs will demonstrate improved lifesaving services and engagement of members in club operations, resulting in engagement and performance.
5. Clubs will demonstrate extended partnerships with external stakeholders and/or demonstrate strategies focusing on engaging the local community and what benefit(s) have been derived.
6. Clubs should identify plans for future development and continuous improvement
7. What would it mean to you to be Club of the Year?

Presentation:

To assist the panel in their selection, finalists for Club of the Year will be required to prepare a presentation on the Clubs successes as related to the criteria of the award. Finalists will be required to present approximately one (1) day prior to the Awards of Excellence Dinner. Each presentation will be given 20 minutes to present, followed by 10 minutes of question and answer time. All questions will be in relation to the submission and the presentation. Each club presenting on the day can have up to two (2) people presenting, SLSA does not specify who should present, however we recommend using club member/s that will best represent your club. Each presenter will have access to a data projector and laptop and all presentations should be brought on a memory stick.



7. Lifeguard of the Year

This award recognises and rewards Australian Lifeguard Service employees who have made an outstanding contribution to the delivery and development of lifeguard services during 2015/16.

Nominees for this award are nominated by the State/Territory Lifeguard Manager or equivalent.

The selection of nominees for Lifeguard of the Year is based on the following criteria:

- Employment standing (position held and total years of service)
- Valuable contribution
- Commitment to public safety
- Achievement
- Work ethic

Essential Criteria – *Nominators to supply proof, where appropriate, via either a printout from Surfguard or equivalent*

1. Employed as a Lifeguard by the Australian Lifeguard Service during the 2015-16 season
2. Surf Life Saving Australia awards/certificates Held
3. Community awards/certificates held (where applicable)
4. Contract term and lifeguard hours (rostered and achieved)

Please note it would be preferable that nominees not hold a supervisors positions.

Selection Criteria – *Nominators to provide responses to the selection criteria below for the period of 1st July 2015 to 30th June 2016*

1. Describe how the nominee has provided a valuable contribution to their lifeguard service (E.g. assisted with training programs, mentored other lifeguards and trainees, gained additional awards, assisted with public relations events etc.)

4. Describe the nominee's work ethic (e.g. well presented, clean uniform, adherence to SOPs, training, no breaches of ALS policies and procedures etc.)

8. Open Age & Youth Athletes of the Year

The purpose of these awards are to recognise and reward both the Open age group and Youth athletes who have demonstrated sporting excellence as well as contributed to the area of surf sports within surf lifesaving.

Essential Criteria

1. Must be an SLSA member in good standing
2. The nominated athlete (teams not eligible) will be an athlete who has demonstrated outstanding achievements and excellence in their chosen discipline in surf sport/s
3. The nominated athletes will be athletes who are good ambassadors of SLSA
4. Youth athletes are categorized as those 15-18 years
5. Open age group athletes are categorized as those 19 years plus

The athlete age is calculated at midnight on the 30th September 2015

9. Coach of the Year

This award recognises and rewards coaches who have made a significant contribution towards the area of coaching within surf lifesaving with regards to both athlete/s performance and the area of coach educational development.

1. Must be an SLSA member in good standing
2. Must be a current accredited surf sports coach throughout the 2015/16 season(attach a current copy of coaching certificate to nomination form)
3. The nominated coach must be a surf coach of any discipline of surf lifesaving competition

Athlete's performance

4. It will need to be demonstrated that the nominated coach has made a significant contribution towards an athlete/s performance in SLSA competition and their development at an international and/or national and/or state level
5. The nominated coaches will be coaches who present a positive image of the role of the coach and of surf lifesaving and demonstrate sound coaching principles and coaching plans

Coach education

6. It will need to be demonstrated that the nominated coach is involved with coach education

3. It will need to be demonstrated that the nominated official has outstanding achievement(s) in respect to lifesaving officiating at an international and/or national and/or state level
4. The nominated surf sports officials will be those who present a positive image of the role of surf sports officiating and surf lifesaving
5. Demonstration that the nominated official is involved with official's education

12. Trainer of the Year

13. Community Education Program of the Year

This award recognises and rewards activities which have significantly worked towards saving lives, creating great Australians and building better communities.
