Summary:	SLSA has undertaken a process to invite interested clubs to submit expressions of interest to host national events in 2015, 2016, 2017 and 2018. This circular confirms the national event locations for the next three years and also asks for feedback from states regarding the proposed dates for the national events.			

BACKGROUND AND PROCESS:

Between April and October 2014, SLSA undertook a process to allocate national events for 2015, 2016, 2017 and 2018.

A summary of the timelines and steps in the process is outlined in the table below:

24 th April 2014	EOI documentation distributed to State/Territory Centres and posted on SLSA website.			
April – June 2014	Briefings conducted between SLSA and interested parties if/as required in accordance with the published EOI documentation.			
5pm, 27 th June 2014	EOI's closed with SLSA			
July – September 2014	EOI's formally assessed against allocation criteria outlined in EOI documentation			
3 rd September 2014	EOI distributed to SLSA bid assessment panel for consideration			
September – October 2014	Questions and impact considerations raised by bid assessment panel addressed by SLSA management and/or national advisors.			
28 th October 2014	Formal recommendation made to SLSA GM Capacity and Capability and SLSA CEO for endorsement.


