## **Additional Information**

- The term of each appointment will end 28 days after the final year of the appointment. o
- For example, the 2020/21 NSW Country Championships Carnival Referee will be required to fulfill this appointment until March 2020 (one month after Country Championships concludes).
- Each appointed senior official will be required to submit a written report during this 28 day period.
- All appointed Officials will be required to attend Championships meetings (including teleconferences) which will be held prior. All times and locations will be outlined in the Officials Appointment Circular distributed at a later date or as otherwise advised by SLSNSW.
- Appointed officials may be responsible for the cost of travel and their own accommodation for the Championships.
- Successful officials must be a currently accredited and a current financial member of a SLSC in the 2020/2021 season.
