Subject:	Grant Opportunity – NSW Gov Crown Reserves Improvement Fund Program 2023-24 (closing 17/11)

Before considering this grant opportunity please note: Surf Life Saving Clubs are only eligible applicants if they have the authorisation of the official manager of the Crown reserve. If you are a surf life saving club located on Crown Land it is mandatory for a signed written authorisation from a Crown Land Manager authorised person to be uploaded as part of an application. Without this the submission is ineligible. There is a template provided by the Department for clubs to obtain this from their relevant Land Manager.

The <u>NSW Gov Crown Reserves Improvement Fund Program 2023-24</u> is now open, <u>closing 17 November 2023</u>. This program provides financial support for the maintenance, improvement and development of Crown reserves.

Funding up to \$1 million is available. Loans up to \$2,000,000 can also be applied for. Average funding awarded last round was \$60,000. Priority will be given to projects that meet all eligibility criteria and best address the following assessment criteria:

- (1) **Community Impact** project contributes to the social, economic cultural and/or environmental advancement of the community by:
- Maintaining or increasing public access, amenity and use of the reserve
- Supporting social cohesion and participation in community life
- Enabling people with accessibility requirements or living with a disability to be included
- Delivering a service or infrastructure to enable Aboriginal people to access, care for, protect and manage land
- Conserving heritage values and/or natural values, and/or
- Creating employment or business opportunities
- (2) Public safety project contributes to ensuring public safety and preventing risk to human life

## Key points to note:

- Applications <u>MUST provide written evidence of support by an authorised person of the reserve's Crown Land Manager</u>. Applications <u>without this evidence cannot be submitted</u>. Please see template attached.
- Crown Land Manager must have no outstanding and/or overdue reporting.
- The number of quotes/cost estimates required is dependent on the value of each activity element:
  - o Activity element amt \$0 to \$30,000 minimum 1 written quote required
  - Activity element amt \$30,001 to \$150,000 minimum of 3 written quotes required
  - Activity element amt \$150,001 or more Acceptable cost estimate and commitment for procurement via a competitive public tender
- Further attachments strongly recommended include letters of support, proposed plan drawings, maps and/or shapefiles, photos
