Summary:	Call for officials' nominations for the 2018 Australian & Interstate Pool Rescue Championships that will be held at the South Australian Aquatic and Leisure Centre from August 3 <sup>rd</sup> – 5 <sup>th</sup> 2018.

SLSA is calling for nominations from all suitably qualified Sports Officials wishing to participate at the 2018 Australian and Interstate Pool Rescue Championships, which will be held at the South Australia Aquatic and Leisure Centre, Oaklands Park.

The Championships will be held over three days: 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> of August 2018.

The appointment of all Officials will be made jointly by the Championship Referee and Surf Life Saving Australia's National Officials Advisor. Officials will be finalised as soon as possible after the close of nomination and all appointments will be posted on the members Portal and 'event info' section of the Pool Rescue webpage. Late nominating Officials will be added to the 'Officials Pool' and duties and appointments made subject to availability of roles.

All officials should ensure they are physically capable to carry out their important functions over the course of the Championships, and are encouraged to undertake a medical check prior to departure to the Championships.

**NOTE:** Preference will be given to those officials able to officiate the full three days but officials that can only attend for 1 or two days are encouraged to nominate as well.

**NOTE:** All appointed officials will be required to attend the officials briefing, prior to competition. All times and location will be outlined in the Officials Appointment Circular distributed at a later date.

**NOTE:** SLSA will be appointing only the required number of officials.

As part of the 2018 Australian and Interstate Pool Rescue Championships safety procedures, the safety and contingency plans will be communicated in detail. Therefore, the Officials briefing is mandatory and failure to attend may result in your appointment being terminated.
