INTRODUCTION:

This event guide contains information in reference to the conduct of the 2019 NSW Interbranch Championship to be held at Bulli SLSC hosted by Illawarra Branch and supported by Surf Life Saving New South Wales (SLSNSW) on Saturday 7 and Sunday 8 December 2019.

A final event memo will be released 1 week prior to the Championship.

The 2019 NSW Interbranch Championship will continue with the same format with some minor improvements identified through the post event review.

EVENT INFORMATION:

Branches will be responsible for the selection of their representative teams and make their own arrangements regarding equipment, transportation of teams and outfitting.

Insurance for all competition equipment including tents, trailers and surf craft is the responsibility of the individual competitors or Branch Team Management. SLSNSW and/or Illawarra will not accept the responsibility for loss, damage or theft of equipment.

BRANCH ENTRIES AND ENTRY FEES:

Branches will be responsible for entering their competitors. Please note that for broadcast purposes, Branches may be required to enter each competitor into their nominated events. ***Please note: Entries will be via new Sport Events Management System (SEMS) or Carnival Manager. SLSNSW will advise Branches in November 2019.***

The entry fee for each competitor is \$27.80 (incl GST) per competitor.

SLSNSW will invoice each Branch after the Championship (including for any drafted competitors).

Entry fees are not refundable if members do not take part in these Championships or if the event is cancelled or suspended.

ELIGIBILITY TO COMPETE:

All entrants must meet SLSNSW award, patrol and proficiency requirements as per the 2019/20 proficiency competition requirements and any other subsequent bulletins issued.

Please note that while Junior Activities members have until 31 Dec 2019 to complete their relevant age requirements, SLSNSW U14 competitors will require an SRC to be able to compete at this event.

It is a Branch requirement to ensure that all competitors are compliant. SLSNSW will conduct a competitor audits to ensure compliancy. <http://www.surflifesaving.com.au/members/resources/administration>. Reference is made to: the current Surf Sports Manual (SSM).

2019 NSW INTERBRANCH CHAMPIONSHIP COMPETITION COMMITTEE:

2019 NSW INTERBRANCH CHAMPIONSHIP SAFETY AND EMERGENCY COMMITTEE:

The 2019 NSW Interbranch Championship Safety and Emergency Committee (SEC) will direct all matters relating to the safety of the competition.

A Safety Operations Manual (SOM) is in place to ensure appropriate procedures are in place if an emergency occurs during a competition.

The objectives of the plan are to:

- Outline the facilities that will be utilised during the event.
- Identify those persons with the authority to initiate the plan.
- Outline command and control functions.
- State the activation methods for internal and external agencies and services.

The SEC shall determine the response to hazards as they occur, or otherwise as required and provide safety advice to the Competition Committee. The sole responsibility for suspension, cancellation, postponement or relocation of part or all of the competition rests with the Competition Committee.

The decision to enact the Contingency Plan is the responsibility of the Competition Committee. The Safety and Emergency Management Coordinator is solely responsible to the Competition Committee for recommendations concerning competition safety.

EVENT CONDITIONS:

The general competitive conditions as detailed in the current edition of the SSM and any subsequent Bulletins shall apply to the conduct of these events except where amended by these Championship rules.

All events where possible and, conditions permitting, shall be conducted as finals. As a result the following event competitor numbers shall be permitted:

- Swim Race and Teams 22 Individuals/11 Teams
- Board Races and Teams 22 Individuals/11 Teams
- Ski Races and Teams 22 Individuals/11 Teams
- Ironman/Ironwoman Races and Teams 22 Individuals/11 Teams

The primary amendments are:

a) Water Courses:

With the exception of the Board Rescue Relay and the Rescue Tube Rescue events all individual and team water events will be conducted around the buoy courses, and distances, set for the individual legs of the Ironperson event (as per the current edition of the SSM) e.g. All Surf Races/Teams (U/12 to Opens) will be conducted only around the string of nine set at a minimum distance of 120 metres.

The Board Rescue Relay and Rescue Tube Rescue events shall be conducted as per the standard courses outlined in the current edition of the SSM.

b) Water Event Starts:

Unless otherwise advised, all water events, with the exception of the Board Rescue Relay and Rescue Tube Rescue shall be started on the beach approximately 15 metres from the water's edge (run start). Craft will be placed in front of the start line and as close as practicable to the water's edge. Handlers are not required for the start of events except for the Ski events where at the Competition Committees discretion handlers may be utilised to hold the craft in the water to avoid the dragging/carrying of skis into the water.

c) Water Event Finishes:

Unless otherwise advised, all water events, with the exception of Board Rescue Relay and Rescue Tube Rescue, shall finish as per the Ironperson races (run finish). Craft and paddles may be abandoned after rounding the last turning buoy of the swim course. Handlers are to be used to remove craft and paddles from the course.

d) Change Over Area and Tagging for Relay Style Events:

In all relay style events (except the Board Rescue Relay) the Carnival Referee will designate a Changeover Area. In the Changeover Area a tag must take place between the incoming competitor and the outgoing competitor. The tag can take place on any part of the body. Any breach of the Changeover Rule may result in disqualification.

e) Entry Condition:

If a Member has been injured and processed through iCare (WorkCover Authority New South Wales) and wishes to compete in a SLSA Competition or returning to SLSA Surf Patrol Duties etc, then they **MUST** complete and submit a Return to Surf Duties Form **BEFORE** returning to ensure full medical clearance.

f) Board Rescue Relay:

Each race to be conducted as follows: with U12, U13 and U14 Male, event as an example:

1. The event is conducted over the normal board rescue course as laid out in the SSM.
2. The race commences with the U12s completing a Board Rescue event as per the SSM.
3. On both U12 competitors crossing the start/finish line in contact with their board, the U13s will then complete a Board Rescue event as per the SSM. (Both U12 competitors must cross the start/finish line between the 2 coloured flags only. It is not a requirement they cross the start/finish line adjacent to their designated marker however the outgoing U13 swimmer and paddler must start from their designated marker. It is the responsibility of the U13 swimmer not to cross the start/finish line until both U12 competitors have crossed the start/ finish line in contact with their board. Any breach of this rule may result in disqualification.)
4. On both U13 competitors crossing the finish line in contact with their board, the U14s will then complete a Board Rescue event as per the SSM. (Both U13 competitors must cross the start/finish line between the 2 coloured flags only. It is not a requirement they cross the start/finish line adjacent to their designated marker however the outgoing U14 swimmer and paddler must start from their designated marker. It is the responsibility of the U14 swimmer not to cross the start/finish line until both U13 competitors have crossed the start/ finish line in contact with their board. Any breach of this rule may result in disqualification.)
5. The finish of the event will be judged on the first U14 team to cross the finish line as outlined in the SSM.
6. If surf and weather conditions permit the event will be conducted utilising 11 cans with each Branch being designated a can and marker at the commencement of the event.
7. If surf and weather conditions do not permit the event to be conducted utilising 11 cans. Heats and finals will be conducted at the discretion of the Carnival Referee.

Notes

Team managers will be required to submit their Team Declaration following the event draw being conducted at the team managers briefing. The Team Declaration will be sent to Team Managers closer to the event.

Note 1: The minimum Team Management composition must contain both Male and Female appointees. In this regard it is recommended that Branches appoint males and females proportionate to the team management size. There is no limit on the Team Management however only 2x Branch representatives will be nominated and permitted to act as Team Managers (for meetings etc.).

Note 2: Refer to SLSA Policy 5.04 "Proficiency and Patrol Hour Requirements for Competition Eligibility". All selected competitors must be proficient to the relative SLSA Award for their age group and, as appropriate, have satisfied the patrol requirements as specified by their Clubs. Competitors and Team Management must also be current financial members of their respective surf club.

Note 3: All Competitors must have their appropriate age group clearly marked on their arms, (i.e. U12, U13, U14, U15, Y or O) as well as their unique competitor number on the back of their hand. These competitor numbers will be sent to Team Managers in the week leading into the Championship.

Note 4: Any substitution/s required by a Branch, can only be made from within the nominated team and can only be substituted from the competitor's same age group. I.e. an injured Under 13 competitor can only be substituted for an existing Under 13 competitor from the same Branch already entered in the competition.



TEAMS:

Branch Team

A Branch Team (40) will consist of the following:

- Age Team: U12, U13, U14 and U15 Age Groups
- Youth Team: U17
- Open Team: U19 and Open

Teams are to be divided up as follows:

Age Team (24):

There are to be a maximum of 3 males and 3 females in each age group from U12 to U15 (inclusive).

Male Youth Team (4):

There are to be a maximum of 4 males in this team.

Female Youth Team (4):

There are to be a maximum of 4 females in this team.

Male Open Team (4):

There are to be a maximum of 4 males. It is a requirement to select at least 1x U19 male. U17 may be selected.

Female Open Team (4):

There are to be a maximum of 4 females in this team. It is a requirement to select at least 1x U19 female. U17 may be selected.

Competitors must compete for the whole of the Interbranch Championship in either the Open or the Youth Team but are not permitted to compete in both.

Team Management

1 x Coach (Minimum Foundation/Level 1)

2x Assistant Coach (Minimum Foundation/Level 1)

1x Manager

3x Chaperones

(There must be an equal balance of male and female management)

Handlers

Each Branch is permitted two handlers to assist with craft. Handlers must wear a Branch competition cap and high visibility garment.

Drafting Arrangements

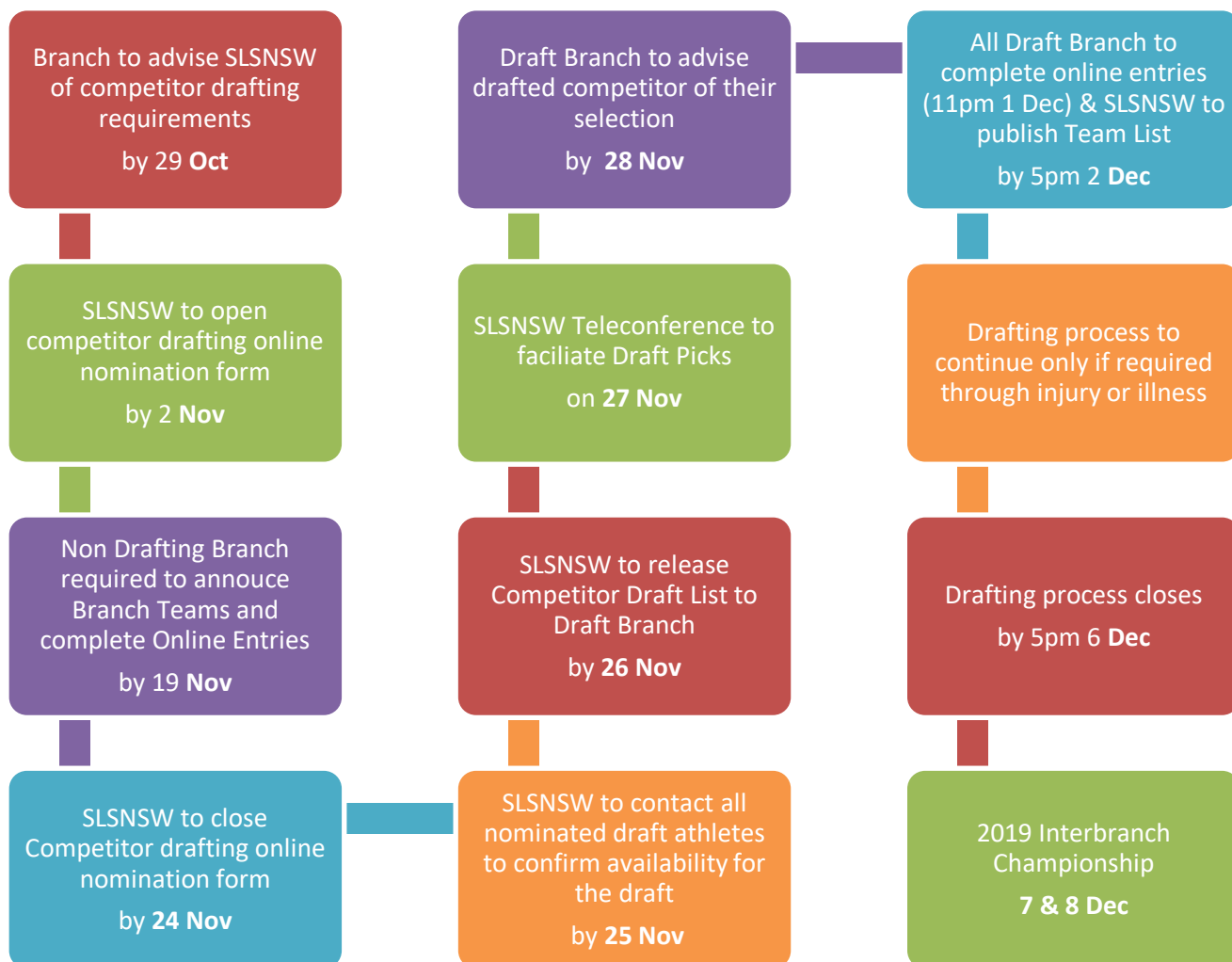
SLSNSW will facilitate a competitor draft to ensure:

- Each Branch has a full team roster for the Youth and Open Teams (where possible).
- That non-selected (from primary Branch) athletic talent is spread around teams requiring draft competitors.
- It is desirable; over time Branch teams become less reliant on drafting to fill Youth and Open Teams.
- To be clear, there is no competitor drafting for Age competitors (U12 – U15).

The draft process shall be as follows:

1. Branches to advise SLSNSW if they will be engaging in the Draft Process by 29 October. The details to be provided will include the age of the competitor (U17, U19 or Open), gender and discipline(s) required and the financial implications.
2. Branches who will not be drafting must announce their teams by 19 November. This will allow competitors not selected for their Primary Branch Team to opt into the NSW Interbranch Draft and it shall be at the individual's financial responsibility (i.e. Drafted individuals will need to discuss with draft Branch as to which, if any costs are to be reimbursed). Branch shall supply a Team Competition cap as a minimum for use at the Interbranch. SLSNSW will invoice the draft Branch for the entry fee for any drafted competitors.
3. SLSNSW will create a pool of draft Interbranch competitors and this will close on Sunday 24 November at 11pm.
4. SLSNSW to make contact with all nominated draft competitors to confirm availability for the draft on Monday 25 November.
5. SLSNSW will release a list of the available draft competitors to each eligible Branch on Tuesday 26 November.
6. There will be a teleconference facilitated by SLSNSW Chair of Selectors (or their nominee) on Wednesday 27 November with eligible Branch Head Coach and/or Manager to complete their draft picks.
7. The lowest placed Branch at the previous Interbranch Championship will have first pick, followed by the next lowest and so on until the first rotation is complete. The rotation will continue until all teams have a complete roster (see last page for overall Branch Pointscore from previous event).
8. Should a drafted competitor subsequently not be available the drafting rotation will not be recommenced but the position filled from the next available eligible competitor.
9. All Branches will need to have completed their online entries by 11pm on Sunday 1 December. SLSNSW will publish the list of all Team Lists on Monday 2 December.
10. The initial drafting process is to be completed by SLSNSW and competitors advised of their selection by their selected Branch team manager a minimum of one week prior to the Championship.
11. Once a competitor has been advised of their draft they will not be able to be selected for their own Branch unless injury or illness occurs to a selected team member. In such circumstances the Branch is to advise SLSNSW in writing of the need to reclaim a competitor. A replacement competitor shall then be identified and allocated to the drafting Branch.
12. It is permitted for the drafting process to continue up until 5pm Thursday 6 December. After this time, any further drafts will be at the discretion of SLSNSW.
13. Any drafted competitors are eligible to earn 100% of their placing points in both individual and team events towards their drafted Branch point score.

Drafting Process Flow Chart Summary



Branch of Origin

The purpose of this is to allow Branch to select competitors who may have been developed in and since moved from the Branch (i.e.; interstate). Branch of Origin competitors can only be selected for the **Open Team**.

Branches are permitted to select “Branch of Origin” competitors based on where the member first gained their Bronze medallion award.

For 2019 a maximum of two Branch of Origin competitor per gender per Branch may be selected.

POINTSORE:

Placing in Finals

Placings in finals will be allocated points on an 11, 10, 9, 8, 7, 6, 5, 4, 3, 2, 1, basis for the positions 1st – 11th, for each event contested.

Individual Events

In individual events, only the first competitor from each Branch to correctly complete the course shall earn points for their Branch team as described in the first paragraph.

Team Events

In Surf Teams, Board Teams, Ski Teams and Ironperson Team Races, placing's shall be determined by allocating 22 points for 1st place across the finish line down to 1 point for the 22nd competitor to correctly finish. Any Branch who competes with less than two competitors in these team events or who has one of their competitors disqualified shall receive 0 points towards the point score for that competitor to determine their team's event placing. The effect of this is all Branch teams are eligible to earn points in team races provided that they have at least one competitor complete the course. Once the team member placing points from each Branch are added together, the team with the highest points shall be declared the winner of the event. The points will then be allocated to the Branch teams as detailed in the first paragraph (i.e. 11 for 1st, 10 for 2nd and so on).

Relay Events

In the Beach Relay, Board Rescue Relay, Cameron and Taplin Relay races the results shall be determined as per the finish order of correct completion of the race and points awarded as per the first paragraph. If it is not possible to conduct the Beach Sprint, Beach Relay, Board Rescue Relay as finals, two heats shall be conducted. The first three place getters in each heat shall qualify for an "A" final and the remainder of the place getters in the heat shall contest a "B" final. Points shall be allocated in the "A" final on an 11, 10, 9, 8, 7, 6 basis and 5, 4, 3, 2, 1 for the "B" final (note that the highest points that can be earned in the "B" final is 5 points). If any team/individual in either the "A" or "B" finals is disqualified they will earn 0 points for their Branch.

Dead Heats

Dead heats in finals in both team and individual events shall be declared as per current Edition of the SSM. Placings shall be awarded as follows: Equal first will result in no second place being awarded with the next placed competitor or team being awarded third place etc. In the event of a three way dead heat for first the next placed competitor or team shall be awarded fourth place and so on.

Overall Branch Pointscore

The Branch with the highest aggregate of points at the conclusion of the competition shall be declared the winner. Further to this when the event has concluded and if there is a tied pointscore, the Branch team with the most 1st placings shall be declared the winner. Failing this, the Branch with the most 2nd placings to the last placing points awarded respectively will be taken into account to determine a winner. If, after this procedure there is no single winner, then the pointscore will be declared a tie and dual trophies will be presented.

Wild Cards

There are no wildcards for the 2019 Interbranch Championship.

PRESENTATIONS:

Branch Teams will be competing for the NSW Interbranch Trophy and the NSW Interbranch Country Point Score Trophy. The Branch Teams placing 1st, 2nd, and 3rd in the NSW Interbranch Championship will also receive Championship medals for all team members.

Please note: The Interstate Team will not be announced at the Championship.

DRAWS AND BALLOTS:

Prior to the event SLSNSW will undertake a draw positioning for each event. Initial draws will be undertaken for the first event conducted in each of the water area and beach area of competition. Subsequent draws will be of the 'rolling draw' format where all Branches will move sideways one beach position in each event conducted in the area. Copies of the first draws will be supplied in the Final Event Memo. A draw for order of the Ironperson, Cameron and Taplin Relay events will be undertaken at the Team Managers meeting. The Referee will undertake any other ballots required on the beach on the day of the competition.

COMPETITION AREAS:

- Both water and beach areas will be run concurrently. Sprints will be followed by Flags.
- One water area and one beach area on Saturday with all beach events to be finalised on the Saturday. One water area on Sunday.
- No event is to be run concurrently with another.

COMPETITION EQUIPMENT AND SPECIFICATIONS:

Each team shall be responsible for the provision of their own surf craft. All equipment used in competition is to comply with SLSA specifications and have been scrutineered and passed for use in SLSNSW competition.

Random scrutineering of equipment will also occur during the Interbranch Championship.

Please note: Each team member must have a pink high visibility vest to be eligible to compete in any water based event. It is a Branch decision if this is to be provided by the Branch or if members must supply their own.

PROTESTS:

All protests shall be lodged with the appropriate Competition Liaison Officer in accordance with the procedures set down in the SSM and any subsequent bulletins, and shall identify the specific sections/clauses in the Competition Manual and or event rules upon which the protest is based.

Protest Forms will be readily available from the Referee Steward. An "Appeals Fee" of \$110.00 (incl GST) must accompany all protest appeals when submitted to the Appeals Committee for adjudication. If the appeal is upheld, then the Appeals Fee will be fully refunded.

INJURY/ILLNESS SUBSTITUTION:

A Branch may replace an athlete in their team up until the commencement of the first event in the championship.

After competition commences a Branch cannot make a replacement from outside of the team.

However, a Branch may substitute an athlete in the same nominated age category from within their team on the following basis:

- A team can substitute an athlete of the same nominated age in an individual event but only before participation in the first heat of the event.
- A team can substitute an athlete of the same nominated age in and out of a team event between heats and further rounds of the event.

In such circumstances the Marshall is to be informed at marshalling.

Further, a Branch may substitute an athlete of a younger nominated age category from within their team but only on the following basis:

- Application must be made through the Referee to the Competition Committee who will make a decision. The Championship Committee's decision shall not be subject to protest or appeal.
- Application for substitution of an athlete can only be for injury or illness. Proof of injury or illness may be sought by the Competition Committee.
- The Competition Committee may permit an U12 to U14 age athlete to compete up one age group only, and an U17 athlete to compete as an U17, U19 and/or Open. An U15 age competitor is not permitted to compete up under any circumstances. An U19 competitor may compete as an U19 and Open.
- Once substituted the injured/ill athlete is not permitted to take any further part in the event.

MEDIA STATEMENTS:

Branches will be permitted to promote the event and their team within their Branch. However, no competitor, team manager, official or spokesperson shall make media statements, which could bring the 2019 Interbranch Championship event into controversy or disrepute. Complaints regarding the organisation of the Interbranch Championship, or any other matters, should be directed through the appropriate SLSNSW channels, and will be dealt with by the responsible section, or Officers. All official complaints will be acknowledged.

PHOTOGRAPHY AND MEDIA:

SLSNSW prohibits the use of drones or Unmanned Aerial Vehicles (UAV) at this competition by members and/or public unless approved by SLSNSW, 7 days prior to the event. The operator must supply an operations manual (including risk management plan), provide a copy of public liability insurance and comply with all Civil Aviation Safety Authority (CASA) requirements.

SLSNSW will not be issuing any media/photography accreditation to team members or team management.

THEFT:

Any person/s found stealing signage or any equipment owned by SLSNSW or its sponsors, will immediately be brought before a Carnival Disciplinary Committee or a SLSNSW Judiciary for possible further action.

Please note that automatic disqualification of the team from the Championship will occur if any member is found guilty of theft.

ANTI-DOPING:

Members have responsibilities under Policy 5.02 Anti-Doping Policy and Policy 6.23 Illicit Drugs in Sport (both available online at Members Area > Document Library > Governance/Policies). Members have a duty to avoid all prohibited substances and prohibited methods and should be aware of the policy if medication is required. If appropriate, advice should be obtained from medical practitioners, pharmacists, the Australian Sports Anti-Doping Authority (<https://checksubstances.asada.gov.au>) or 13000 ASADA (1300 027 232).

It is strongly recommended that all Team Managers complete the Anti-Doping Level 1 course via the ASADA website at <http://elearning.asada.gov.au/index.php> which will provide information on how to keep Australian sport clean from illicit and banned substances as well as how to keep updated with changes on the banned substances list. Once you have completed the course, please email the certificate to surfsports@surflifesaving.com.au to have this added your surfguard profile as a recognised award. If you have previously completed the Anti-Doping Certificate this is valid indefinitely.

BEHAVIOUR/MISCONDUCT:

Misconduct before, during and after the Championships will not be tolerated. Offending members risk disciplinary action against themselves and their clubs.

Please refer to current Surf Sports Manual sections 2.27 SLSA Code of Behaviour and 2.28 Abuse/Inappropriate Behaviour and the Policy 6.05 – Member Protection Policy (available online at Members Area > Document Library > Governance/Policies).

MATCH FIXING:

Members have responsibilities under Policy 5.11 National Policy on Match-Fixing (available online at SLSA Members Area > Document Library > Governance/Policies) To assist members understand what Match-Fixing is and how it can affect our sport, it is recommended to complete the Match-Fixing online course at <https://elearning.sport.gov.au/> This e-learning program is designed to help you understand what match-fixing is, its consequences, how to recognise it and report it. Once you have successfully completed the modules you will know how to effectively keep Australian sport honest and you will receive a congratulations email, please forward this surfsports@surflifesaving.com.au to have this award uploaded your surfguard profile as a recognised award. If you have previously completed the Match Fixing Certificate this is valid indefinitely.

Both the above ASADA and Match-Fixing online courses are free of charge and provide an opportunity to develop a knowledge and understanding of Anti-Doping and Match-Fixing in sport. Moving forward, SLSNSW strongly believe this is a great additive to the structure of any Surf Lifesaving competition and provides vital education for any athlete, coach and official.
