Subject:	Disaster Assistance for Individuals and Organisations – NSW Bushfires from August 2019 onwards

In response to the NSW bushfires from August 2019 to February 2020, assistance has been activated for affected individuals and organisations.

Below are the details of the current grants and other forms of assistance that individual members and clubs may wish to consider if they have been affected by the recent and ongoing disasters.

- 1. For Individuals:
  - a. Centrelink Disaster Recovery Allowance and Disaster Recovery Payment
  - b. Centrelink Crisis and Special Payments
  - c. Disaster Relief Grants (Administered by the NSW State Government via the Office of Emergency Management)
  - d. Other Assistance including Financials Support for Volunteer Fire Fighters
- 2. For Organisations:
  - a. Natural Disaster Grants Not-for-Profit Organisations

Eligibility criteria apply to these grants.

#### FOR INDIVIDUALS - CENTRELINK DISASTER RECOVERY ALLOWANCE AND PAYMENT

#### **Disaster Recovery Allowance**

Disaster Recovery Allowance is a short term payment to help you if a declared disaster directly affects your income. You can get it for a maximum of 13 weeks. It's payable from the date you lose income as a direct result of the NSW Bushfires from August 2019 through to February 2020.

To get Disaster Recovery Allowance you must:

- be 16 years or older at the time of the fire and not a dependent child
- be an Australian resident or hold an eligible visa
- get an income by working in an affected Local Government Area (LGA) or live in an affected LGA
- lose income as a direct result of the NSW Bushfires in August, September, October, November, December 2019 and/or January, February 2020
- show you will earn less than the relevant income threshold amount in the fortnight following the loss of income.

You have until **4 August 2020** to make a claim for the following LGAs:

#### Australian Government Disaster Recovery Payment

The Australian Government Disaster Recovery Payment provides one-off financial assistance to eligible Australians adversely affected by the fires.

The rate of this Payment is \$1,000 per eligible adult and \$400 per eligible child. Claims for this payment can be lodged with the Department of Human Services for a period up to six months.

To get the Australian Government Disaster Recovery Payment you must:

- be an Australian resident or hold an eligible visa
- be 16 years or older at the time of the fire or getting a social security payment
- have not already received an Australian Government Disaster Recovery Payment for NSW Bushfires in August, September, October, November, December 2019, January 2020 and February 2020.

You also need to have been adversely affected by the fire. For example: you have been seriously injured; your principle place of residence has been destroyed or must be demolished; your principle place of residence has been declared structurally unsound; you're the principal carer of a dependent child who has experienced any of the above; etc. For the full list please visit <u>https://www.servicesaustralia.gov.au/individuals/services/centrelink/nsw-bushfires-september-2019-australian-government-disaster-recovery-payment</u>.

You have until 4 August 2020 to make a claim for the following LGAs:

## FOR INDIVIDUALS - CENTRELINK CRISIS AND SPECIAL PAYMENTS

Persons not eligible for Disaster Recovery Allowance and/or Disaster Recovery Payment, but affected by extreme circumstances may be eligible for support payments from Centrelink. ### FOR INDIVIDUALS - DISASTER RELIEF GRANTS

If you are not insured and have limited income, you may be eligible for a disaster relief grant.

- Grants are available for eligible individuals and families whose homes and essential household contents have been damaged or destroyed by a natural disaster.
- To be eligible for this assistance you must be a low-income earner and meet an income assets test; demonstrate that the affected home is your principal place of residence; not be covered by insurance; demonstrate that the damage was caused by the disaster; and lodge the application within four months of the disaster occurring.

## FOR INDIVIDUALS - OTHER ASSISTANCE

Those affected by extreme circumstances may be eligible for the following:

- Clean Up Assistance
  - If your property is insured, contact your insurer about clean-up.
    - If you are uninsured and your home has been damaged or destroyed, Public Works Advisory will arrange for the clean-up of your residence. Please contact Public Works Advisory on 1800 88 55 39.
- Housing assistance from NSW Department of Communities and Justice: social housing providers can provide support and assistance to people who are affected as a direct result of natural disasters. This assistance may include temporary accommodation and emergency temporary accommodation. Call
  - Link2Home 1800 152 152 for temporary accommodation. This information and referral service is open 24 hours a day, 7 days a week.
  - DCJ Housing Contact Centre 1800 422 322. This contact centre is open 24 hours a day, 7 days a week.
- Australian Red Cross Emergency Grant: persons whose home has been destroyed or rendered uninhabitable in a bushfire since July 2019 can apply for an emergency grant of \$5,000 <u>https://www.redcross.org.au/get-help/emergencies/recovering-from-emergencies/direct-assistance-application</u>
- Australian Red Cross Register Find Reunite: this service registers, finds and reunites family, friends and loved ones after an emergency. <u>https://register.redcross.org.au/</u>.
- NSW Bushfire Housing Assistance Service: this service an assist people who are temporarily or permanently
  displaced from their home as a result of the bushfires. It can provide emergency accommodation and assist in

- P2/N95 masks: the NSW Government is distributing Commonwealth-provided P2 masks to community

# FOR INDIVIDUALS - FINANCIAL SUPPORT FOR VOLUNTEER FIRE FIGHTERS

- Rural Fire Service Volunteers in NSW who are self-employed or work for small and medium businesses (businesses with a turnover of less than \$50 million in the 2018-19 financial year), and who have been called out for more than 10 days this fire season, will be able to apply for the payments of up to \$300 per day up to a total of up to \$6,000 per person.
  - Payments are expected to be available before the end of January 2020. In the interim, volunteer firefighters may register their interest in accessing the program at <a href="https://www.service.nsw.gov.au/transaction/register-interest-volunteer-firefighters-financial-support-program">https://www.service.nsw.gov.au/transaction/register-interest-volunteer-firefighters-financial-support-program</a>.
- Federal Government employees fighting bushfires are eligible for increased paid volunteer leave allowance. Commonwealth public service leaders are to offer at least 20 working days paid leave, or 28 calendar days, for volunteers aiding with firefighting efforts. And for additional leave to then be provided as when needed. ## FOR ORGANISATIONS - NATURAL DISASTER GRANTS NOT-FOR-PROFIT ORGANISATIONS

Eligible not-for-profit organisations and small businesses that have suffered direct damage to their premises or equipment as a result of the 2019-20 bushfires may be eligible for a bushfire recovery grant.
