#### Nomination Process

- Review the current Surf Sports Manual – section 10 “Officials and their Duties”
- To nominate for the senior official position for the above championships please follow the link [online](#) and complete the nomination form. Please note nominations close **11pm Wednesday 24 March 2021**
- SLSNSW will collate the nomination results and successful candidates will be notified thereafter.

#### **Additional Information**

- All Senior Official appointments will be for the duration of ONE season.
- The term of each appointment will end **28 days** after the final year of the appointment.
  - For instance, the 2021 NSW Sharkskin IRB Premiership Round 4 Carnival Referee will be required to fulfil this appointment until July 2021 (one month after IRB Premiership Round concludes).
  - Each appointed senior official will be required to submit a written report during this **28 day period**.
- All appointed Officials will be required to attend Premiership meetings (including teleconferences) which will be held prior. All times and locations will be outlined in the Officials Appointment Circular distributed at a later date or as otherwise advised by SLSNSW.
- Appointed officials may be responsible for the cost of travel and their own accommodation for the Championships.
- Successful officials must be currently accredited and a current financial member of the SLSC that you are officiating for during the 2020/2021 season.

#### **Medical Form**

- All Officials should ensure that they are physically capable to carry out their important functions over the days of the Premiership, and are encouraged to undertake a medical check prior to the departure to the Premiership.
