## Calling for nominations for Surf Life Saving New South Wales Director Positions

Surf Life Saving New South Wales (SLSNSW) is calling for nominations for 2 x SLSNSW Director positions for a 3 year term as outlined in the attached form.

Please note that the positions to be voted on at the Election Meeting on Saturday, 8 May 2021 will be for the positions of Deputy President (Specified Director) and 1 x Director position (Unspecified Director).

As per The SLSNSW Constitution (Schedule 1, Electoral Procedure, Nominations and Notices), all nominees must first nominate for an Unspecified Director position and must also state if they wish to nominate for any Specified Director position available at that Election. All Election material will denote where a nominee has also nominated for a Specified Director position.

On this occasion, the SLSNSW Board is seeking nominees with a strong understanding and commitment to membership based strategies, inclusive of but not limited to recruitment and retention, leadership development, member welfare and safeguarding children and inclusion commitment.
