The following conflict of interest guide has been created for the Awards of Excellence Panels and should a panel member have a conflict of interest they are required to stand down from the panel, and the two-year term. Conflicts of interest will result in changes to the selection panels including the appointment of the reserve panel member.

Guide to determine if a conflict of interest:

- If you have written the application
- If you are from the same club as the finalist
- If you are the finalist
- If the finalist is a family member
- If you are a Branch and/or State Director
- If you are a Branch or State staff member

Each panel will consist of three members and a reserve (to be appointed should a conflict of interest occur).

Candidates interested in expressing an interest for any position should send the attached signed nomination form to the SLSNSW Chief Executive Officer along with a typed copy of your resume (1 page maximum) which details your credentials and relevant experience for the position/s to assist the Standing Committee Chairs to make a decision about the suitability of the candidates for the position/s.

The attached nomination form needs to be forwarded to the Surf Life Saving NSW Chief Executive Officer by noon, Monday, 12 April 2021.
