Subject:	Grant Opportunity – Shoalhaven City Council's Bushfire Recovery Grants (closing 6 August 2021)		

The Shoalhaven City Council's Bushfire Recovery Grants are now open closing 6 August 2021.

- <u>Up to \$1,000 for small projects and up to \$10,000</u> for projects that contribute to community improvement, wellbeing, resilience and recovery and assist communities and individuals to overcome the social impacts of the bushfires.
- Proposed projects must meet the following criteria:
  - o Bring communities together in a supportive environment through activities
  - o Deliver grassroots, community-led health and wellbeing activities that build community resilience
  - o Facilitate programs that enhance the communities' disaster preparedness skills
  - o Locally led activities that support communities in recovery
  - o Support community led bushfire commemoration initiatives
  - Events must be held in the Shoalhaven Local Government Area
- Proposed projects will be assessed on how effectively the project:
  - Will improve community's ability to respond to future disasters, and to foster community social connection and improved health and wellbeing.
  - Application provides detailed costs showing that the project is achievable and cost-effective and provides a low cost or no cost opportunity for participants
  - Application details a success outcomes and measurement process

## **Key points:**

- Required attachments include but are not limited to: quotes; latest annual report; latest financial report; evidence of relevant insurance/s; evidence of not-for-profit status; a COVID Safe Plan; and child protection policy if the proposed activity involves children.
- Applications should aim to limit funding requests for materials or equipment, rather focusing on applying for project/event related costs.
- Applicants must acquit any previous Council grants prior to applying and have no debts with Council.
