Fingal Beach SLSC, NSW from 22-25 July 2021.

Information Summary:

- The Australian & Interstate IRB Championships will be held from 22nd -25th July 2021 at Fingal Beach, NSW.
- Scrutineering to commence from Wednesday 21 July from 9am. This is pending availability of Officials. A scrutineering roster will be sent to clubs to allocate a time.
- Entries are now open through the Sports Events Management System (SEMS). Clubs who do not have a SEMS login are to request access first by completing the <u>IT Systems User Account Application Form</u>.
- Normal entries close 5pm on Friday 9th July 2021. Late Entries close 5pm on Friday 16th July 2021
- Trailers/Containers can be dropped at the site from 12pm on Tuesday 20th July 2021. If any clubs are sending containers you must contact events@slsa.asn.au with all details listed.
- Team Managers must complete <u>IRB Championships Team Manager Form.</u>
- Download and complete Training Log Summary Sheet from <u>IRB Champs webpage</u> submitted to <u>events@slsa.asn.au</u> by close of normal entries.
- Every Club must submit full training logs to the Administration Centre prior to competition.

COVID STATEMENT

While SLSA is calling for entries for all regular events to be held at the Australian & Interstate IRB Championships, due to potential COVID-19 restrictions in place at the time of the event (border closures, social distancing, venue numbers, quarantine requirements etc.), SLSA reserves the right to reduce both the number of events and the number of participants per event as well as the order in which events will be held. It is currently not possible to predict the impact of COVID-19 for an event to be held in July. Members must make their own assessment in relation to entries.

This document has been prepared with the best intentions based on current State Health Authority information regarding COVID-19 restrictions and related border movements. However, as has been noted over many months this information is constantly changing and as such all athletes, coaches and supporters should be prepared to allow for some flexibility in their planning. SLSA will do their best to provide advance notice on the listed options and possible further amendments however, again, as has been witnessed over many months COVID-19 restrictions can be amended with little to no notice by the various State Health Authorities.

SLSA is actively working with NSW Health and the Port Stephens Council to finalise the COVID Safe Plan for the Championships. Due to the dynamic nature of the COVID-19 pandemic, and related restrictions, SLSA cannot guarantee there will be no amendments to the event and/or the timetable of races leading into and during the Championships. All endeavours are being examined and discussed to keep the event as normal as possible however SLSA acknowledges that due to the COVID-19 pandemic there are likely to be restrictions in some form placed on the Championships.

Once an invoice for clubs entry fees has been generated, all entry fees are non-refundable.

IRB CHAMPIONSHIPS COMPETITION COMMITTEE

The IRB Championship Competition Committee (IRBCCC) will direct all matters relating to the actual conduct of the competition. The IRB Championship Competition Committee may, subject to the rules in the <u>36th Revised Edition Surf Sports Manual</u> (SSM) and event rules, any subsequent amending bulletins and this circular, may postpone, cancel and/or alter any or all Championship events, and alter the venue of the competition.

A review of the following matters will be included for discussion at each Competition Committee meeting:

- a) Risk assessment of the current conditions of the beach and back of beach area
- b) Injury management statistics
- c) Current weather predictions
- d) Competition statistics

The IRBCCC may consult and seek advice from appropriate Officials, athletes and other personnel on local weather, surf conditions and safety issues when required. The IRBCCC shall appoint the various sub committees and panels as required for the Championships (e.g. Disciplinary Committee).

The IRBCCC is responsible for enacting the contingency plan for the Australian & Interstate IRB Championships. The Championship Referee and the Safety and Emergency Management Coordinator (SEMC) are responsible to the IRBCCC for recommendations concerning competition safety. The Safety Operations Manual developed for this event is to be applied by the Championship Referee and the SEMC in considering and making recommendations, in consultation with relevant emergency services and lifesaving authorities.

AUSTRALIAN IRB & INTERSTATE CHAMPIONSHIPS: 22 - 25 July 2021

The Australian IRB & Interstate Championships 2021 is a competition matching the best representative Inflatable Rescue Boat (IRB) teams from Australia's Surf Clubs, States and Territories.

This actioned packed event will showcase the expertise of each Club in the use of IRBs, Surf Life Saving Australia's frontline of rescue methods. Club teams will battle it out in the open ocean for the Harry Brown OAM Trophy for the Australian IRB Championship point score. The best crews from each State will also compete for the SLSA Interstate IRB Championship Trophy and contribute points to the Alan B Whelpton AO Perpetual Shield (for the overall Interstate point score of Ocean, Pool, Surf Boat and IRB Interstate Championships).

SAFETY

All Clubs, States & Territories, Competitors and Officials are referred to the introduction of the 36th edition of the SLSA Surf Sports Manual. Paragraph (d) states:

"Surf lifesaving can be inherently dangerous. Serious accidents can and often do happen which may result in property damage, physical injury and even death. All members are assumed to have voluntarily read and understood this warning and accept and assume the inherent risks in surf lifesaving."

All Clubs, States & Territories, Competitors and Officials are also referred to the General Rules contained in the SLSA IRB Competition Rules Section 3.3 and in particular to the warning contained in SSM Section 3.3.2.1 that states:

"WARNING: IRB competition can be inherently dangerous. IRB competition participants acknowledge that they are exposed to certain risks during IRB competition including but not limited to leg, spinal and neck injuries, physical exertion, contact with the IRB, temperature, weather and water conditions



and even drowning. IRB competition participants acknowledge that accidents can and often do happen which may result in IRB competition participants being injured or even killed. All members through their participation in IRB events agree with, acknowledge and understand this warning and accept and assume the inherent risks in IRB competition."

An Australian & Interstate IRB Championships 2021 Safety Operations Manual, including a Competition Contingency Plan has been developed for use by the IRBCCC, Officials and relevant personnel. The Championship Referee and SEMC will give a Safety Briefing to Officials and Team Managers before commencement of competition and during the event as required.

Water safety as part of the competition, is ultimately the responsibility of the IRBCCC. In accordance with Section 1 - Competition Safety, of the current edition of the SLSA Surf Sports Manual, any subsequent amending bulletins, and this circular, the IRBCCC is responsible to determine whether to postpone or cancel any or all events or relocate the Championships to an alternate venue based on the advice of the SEMC, Championship Referee and Officials.

In response to ongoing reviews of carnival safety measures additional Risk Assessors have been appointed to assist the SEMC to provide ongoing assessment of conditions and safety across the carnival area. They will create an effective communications channel to the SEMC and IRBCCC. Those Officials may seek advice from competitors and team representatives to ensure an informed opinion is provided and can be acted upon where appropriate.

A debrief with Officials will be conducted by the Championship Referee at the end of each day. Competitor/Team Manager Briefings will be called when required by the Championship Referee. These briefings will be conducted by the Championship Referee and/or Deputy Referee.

SCRUTINEERING

Full technical scrutineering will be conducted for all clubs on <u>Wednesday 21 July ONLY</u>. All scrutineering to be done in accordance with IRB Equipment Requirements, Scrutineering and Compliance. Clubs are made aware that there will be ongoing random scrutineering and equipment reviews throughout the competition days and may be called again for full technical scrutineering at the end of each day of competition.

Note: It is the responsibility of each Club to ensure gear and equipment meets the manufacturers and/or SLSA specifications as set out in the current edition SLSA Bulletin Surf Sport IRB Competition - Gear and Equipment Regulations (or as amended).

Any Club found to be using equipment that does not meet manufacturers or SLSA Bulletin Surf Sport IRB Competition - Gear and Equipment Regulations, shall be referred to the Championship Referee for adjudication. Any equipment that does not meet these regulations will be excluded from the Championships and may face further disciplinary action.

If the failed equipment item / part is subsequently found to be used in Competition, the Club will be immediately disqualified from the Championships, where Coaches, Team Managers and athletes may face further disciplinary action. No competition points will accrue.

CONDITIONS OF ENTRY

DECLARATION

It is an expressed condition of accepting entries that the Team Manager accepts the online form to indicate that all members listed on the Club's entries comply with all entry conditions and shall abide by the conditions of entry set out in this circular.

PROFICIENCY AND PATROL REQUIREMENTS

All competitors entered in the Australian & Interstate IRB Championships 2021 must meet the requirements of SLSA policies. Further details may be obtained from Surf Life Saving Australia's Policy 5.4 – SLSA Guidelines for Competition Eligibility.



Notwithstanding the foregoing, Surf Life Saving Australia reserves the right to conduct a random or detailed audit of entries and under such circumstances, the selected Clubs will be required to submit appropriate documentation to substantiate the eligibility of those members entered.

COMPETITOR PRE-REQUISITES

It is an expressed condition of entering the Australian & Interstate IRB Championships 2021 that a currently licensed accredited Surf Coach indicates that all members listed on the entries comply with the competitor pre-requisites as set out below.

Competitors entering the IRB Championships 2021 must comply with the competitor pre-requisites for drivers, crew and patients as outlined in the current edition of the SLSA Surf Sports Manual and any other subsequent circulars bulletins except where amended by this Circular.

3.3.2.4 Competitor Pre-Requisites

At the date of entry closure for the competition to be contested:

- (a) Drivers are required to:
 - (i) Be a minimum of seventeen years of age as at the date of competition.
 - (ii) Hold their relevant state/territory maritime licence required to operate an IRB.
 - (iii) Hold their IRB drivers award and be currently proficient as required by SLSA and have logged twenty (20) hours specific in-water IRB competition driving training under the supervision of a currently accredited SLSA Coach IRB Events Elective.
 - **Note:** Once the initial 20 hours has been signed off there is no minimum hour requirement required for future years provided that the driver holds the IRB driver's award and is currently proficient as required by SLSA.
 - (iv) Be endorsed by a currently accredited SLSA Coach IRB Events Elective as being competent for IRB competition.
 - **Note 1:** Once the initial 20 hours has been signed off, an annual competition competency endorsement is required by a currently accredited SLSA Coach IRB Events Elective.
 - **Note 2:** In all training and competition it is compulsory for drivers to wear high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejackets or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets. See also Section 2 of the Surf Sports Manual.
 - **Note 3:** The wearing of approved helmets is optional for drivers in both training and in competition. See also Section 2 of the Surf Sports Manual.
- (b) Crewpersons are required to:
 - (i) Be a minimum of sixteen years of age as at the date of competition.
 - (ii) Hold their IRB crewpersons award and be currently proficient as required by SLSA and have logged twenty (20) hours specific in-water IRB competition driving or crewing training under the supervision of a currently accredited SLSA Coach IRB Events Elective.
 - **Note:** Once the initial 20 hours has been signed off there is no minimum hour requirement required for future years provided that the crewperson holds the IRB crewperson's award and is currently proficient as required by SLSA.
 - (iii) Be endorsed by a currently accredited SLSA Coach IRB Events Elective as being competent for IRB competition.



Note 1: Once the initial 20 hours has been signed off, an annual competition competency endorsement is required by a currently accredited SLSA Coach – IRB Events Elective.

Note 2: In all training and competition it is compulsory for crewpersons to wear high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejackets or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets. See also Section 2 of the Surf Sports Manual.

Note 3: The wearing of approved helmets is optional for crewpersons in both training and in competition. See also Section 2 of the Surf Sports Manual.

(c) Patients are required to:

- (i) Be a minimum of fifteen years of age before October 01 in the season the competition is being conducted.
- (ii) Hold their IRB crewpersons award and be currently proficient as required by SLSA and have logged twenty (20) hours specific in-water IRB competition driving or crewing training under the supervision of a currently accredited SLSA Coach IRB Events Elective.
 - **Note:** Once the initial 20 hours has been signed off there is no minimum hour requirement required for future years provided that the crewperson holds the IRB crewperson's award and is currently proficient as required by SLSA.
- (iii) Be endorsed by a currently accredited SLSA Coach IRB Events Elective as being competent for IRB competition.
 - **Note 1:** Once the initial 20 hours has been signed off, an annual competition competency endorsement is required by a currently accredited SLSA Coach IRB Events Elective.
 - **Note 2:** In all training and competition it is compulsory for patients to wear high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejackets or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets. See also Section 2 of the Surf Sports Manual.
 - **Note 3:** The wearing of approved helmets is compulsory for patients both training and in competition (except the Rescue Tube Race where it is optional). See also Section 2 of the Surf Sports Manual.
- (d) Handlers, at the date of competition, are required to:
 - (i) Be a minimum of fifteen years of age before October 01 in the season the competition is being conducted.
 - (ii) Hold the IRB crewpersons certificate and be currently proficient as required by SLSA.
 - (iii) Be a member of the same club or team as the crews and be entered at the competition (exemption may be given by the Championship Referee for a member of another club or team to be a Handler provided that the handler is entered at the competition).
 - (iv) Wear a competition cap and shall be required to wear a distinctive high visibility pink, orange, yellow, green or red coloured vest as determined by SLSA (or relevant SLS Event Organiser) if entering the water beyond knee depth.
 - Alternatively, handlers may wear a high visibility (conspicuous colour) SLSA approved level 50 Australian Standard (AS4758) lifejacket or Type 2 (AS1499-1996) lifejackets. (Level 50S lifejackets unless listed on the SLSA Approved Gear and Equipment List are not approved.) It is not required for high visibility safety vests to be worn over the top of lifejackets.
 - (v) Comply with all instructions of the officials.



- (vi) Make every effort to ensure that they, or the equipment that they are handling, does not impede another crew, otherwise both their competitor and the handler may be subject to disqualification.
- (e) Competitors should be conversant with all current specifications, competition rules and event conditions etc. pertaining to IRB competition and comply accordingly. Attention is also drawn to other relevant sections of the Surf Sports Manual including Section 2 General Competitive Conditions and any other relevant circulars or bulletins that must also be complied with.

TRAINING LOGS

It is a condition of entry into these Championships that all Club Surf Coaches must complete and sign the Training Log Summary Sheet. Please email the forms to Events at events@slsa.asn.au by Thursday 1 July 2021.

Minimum requirements for training under a suitably qualified and currently licensed Surf Coach will be audited and shortfalls in training hours will not be tolerated. By signing this form, the Club Coach certifies that each competitor has satisfied the IRB training requirements as described in the current edition of SLSA Surf Sports Manual and any other subsequent circulars bulletins except where amended by this circular.

<u>Please note:</u> Copies of daily training logs may be requested at the Championships for auditing purposes and it is a condition of entry that each Club Coach provides these to SLSA if requested. If Clubs do not submit their training logs when requested, they will not be allowed to compete.

ENTRY LIMITATIONS

All Interstate IRB Championships events shall be contested by teams representing their State. States shall enter only one team in each event.

All Australian IRB Championships events shall be contested by teams representing Clubs. Clubs are able to enter as many eligible crews as they wish into the Open IRB Championships, Masters IRB Championships and U23 IRB Championships for 2021 providing each competitor complies with the entry limitations as detailed in the current edition of SLSA Surf Sports Manual (detailed under) and any other subsequent circulars or bulletins.

3.3.2.5 Entry Limitations

- (a) IRB competition may be conducted in different categories of age, grade and gender.
 - **Note:** The age divisions conducted at the Australian IRB Championships are Open, U23 and Masters. The Interstate Championships are conducted in the Open Division only.
- (b) Apart from IRB Relay events, a competitor may not compete or nominate to compete in more than eight events at any one competition. IRB Relay events may be entered in addition to this eight event maximum.
- (c) A driver and/or crew may compete in a particular event once e.g. a driver cannot compete in an event in one team as a driver and compete again in the same event as a driver or crewperson in a separate team.

Note: This does not preclude an eligible driver, crew or patient from the same team swapping roles in different rounds of the same event.



- (d) If eligible to compete in multiple grades or age categories, drivers and crewpersons may do so, but may only compete in a particular event once e.g., open male rescue is a different event to the under 23 male rescue (refer to Competition Definitions in Section 2 for further detail).
- (e) IRB patients are to be considered as gender neutral with respect to their participation in male and female IRB events.
- (f) Patients may compete in any grade, age or gender category events but may only compete in a particular event once.
- (g) Attention is also drawn to other relevant sections of the Surf Sports Manual including *Section 2 General Competitive Conditions* and any other relevant circulars or bulletins which must also be complied with.

Competition Priorities and Tiering of Events

Competition will commence on Thursday 22 July 2021.

The Australian & Interstate IRB Championships 2021 will be conducted within strict and challenging timeframes.

These timeframes have received additional pressure due to the inclusion of the Under 23's category to the Championships and the (now) increased eligibility of competitors to compete in up to eight events across two Championships.

In order to meet these timeframes, in their sole discretion, the IRBCCC and the Championships Referees may need to make adjustments to the order, draws and priority of event and priority of the Championships completion. Competition time schedule is any time (in required daylight) from 7:30am on Thursday 22 July – 4:30pm on Sunday 25 July. All teams need to be available to compete at these times. This also includes:

- Cuts in rounds in excess of the numbers as outlined in the Surf Sports Manual for either or both Masters and U23 Championship events
- Cuts in rounds in excess of the numbers as outlined in the Surf Sports Manual for the Opens Championships.
- The priority/tiering of events (from highest to least) is seen as:
 - o Surf Rescue
 - o Mass Rescue
 - o Teams Rescue
 - o Tube Rescue
 - o IRB Relay
- The priority for completion remains for the Australian Open IRB Championships and schedule and conduct of events may change and commence any time from 7:30am Thursday 22 July i.e. Opens may commence on Thursday 22 July.
- In the event of adverse weather and/or other conditions or event time constraints impacting
 on the timely completion of the Championships, preference will be given to the Australian
 Open IRB Championships.

INTERNATIONAL COMPETITORS/TEAMS

Conditions of entry for International competitors:

- 1. SLSA reserves the right to invite and/or accept entries from International competitors and club teams to compete in any event at the Australian IRB Championships.
- 2. International club teams must be a genuine club team (not composite) and must compete in



- club colours to be eligible to compete.
- 3. All international competitors and club teams must gain international clearance from their governing body and must be submitted to SLSA prior to competition to compete at the Australian IRB Championships 2021.

RESERVES

Reserve competitors may be entered into the carnival to avoid late entry fees when making substitutions at the event. All reserve competitors must meet the respective requirements for the position in which they have been nominated as a reserve.

SUBSTITUTIONS

Substitutions will be allowed as per the current edition of the Surf Sports Manual (as long as the competitor is entered into the Championships) and no charge will be taken to make these changes.

If a substitution occurs with a new competitor who is not entered into the competition - this will be considered a late entry and they will be charged accordingly (see Late Entry section in this circular). In this situation advice and competitor's details must be provided to the event administration by 5pm Wednesday 21 July 2021.

Any competitor substituted into an event must meet the correct requirements as set out by SLSA for the position for which they are substituted into.

In the case of a genuine injury the IRBCCC may consider an application for a substitution of an eligible driver or crew (but not both) who has already competed in a different age category of the same event into an older or younger age category of the event.

MEMBERSHIP CLASSIFICATIONS

Please ensure that a membership classification as listed below is filled in for each competitor. Active

PENALTIES: BREACH OF ENTRY REGULATIONS

It is mandatory that all competitors be listed in SEMS for each Club. Entry of competitors who are ineligible due to non-qualification or proficiency, default of personal patrol hour obligations, or other breach of association or club entry regulations will be referred to SLSA for action.

EQUIPMENT

COMPETITION EQUIPMENT

Each Club/State shall be responsible for provision of their team's equipment. Insurance generally shall be the responsibility of the individual competitors, their Clubs or State/Territory. Surf Life Saving Australia will not accept responsibility for loss, damage, or theft of equipment.

If your Club or State is shipping a container to Fingal Beach, please ensure it is a maximum of a 20ft container. If containers are greater than 20ft, they will be parked offsite. There will not be a Manitou forklift on site so please ensure the trucks delivering the containers can offload them.

Deliveries to site can be received from 12:00pm Tuesday 20 July – 4:00pm Thursday 22 July. Exact location for deliveries will be confirmed upon receipt of your container information details.

SCRUTINEERING

All IRBs, motors, and accessories (including fuel) must be scrutineered prior to competition and must have passed the safety and compliance checks conducted by the Scrutineers or as determined by Surf Life Saving Australia.

Scrutineering will be conducted in accordance to IRB Equipment Requirements, Scrutineering and Compliance. Technical scrutineering (including fuel) may also take place randomly before competition, during competition or at the conclusion of the championships.

Any equipment (including fuel) that has not passed the scrutineering requirements shall be referred to the Championship Referee for adjudication.

The scrutineering area will be open on Wednesday 21 July from 8:00am (pending Official's availability) for teams scheduled to compete on Thursday. All Scrutineering must be completed by 4pm on the Thursday. All IRBs, motors and accessories must be scrutineered within these times and prior to competing. Scrutineering will occur in the Scrutineering area of the gear & equipment compound at the back of Fingal Beach (TBC in the Final Carnival Circular) and a Scrutineering Timetable will be sent to Team Managers and posted on the SLSA Website prior to the Championships.

PERSONAL PROTECTIVE EQUIPMENT

Competing clubs and competitors are reminded that:

- The list of SLSA lifejackets approved **for both** lifesaving operations and IRB competition is detailed in the SLSA IRB Gear and Equipment Regulations.
- All certified level 50 Australian Standard (AS4758) and Type 2" (AS1499-1996) life jackets are approved for IRB competitions provided that they are in high visibility (conspicuous) colour.
- SLSA does not permit the use of lifejackets or PFDs designed for use in surf skis, ocean kayaking, or other paddle sports, i.e., the design must be consistent with the lifejackets approved for SLSA lifesaving operations as detailed below.
- Other than the SLSA branded Rip Curl lifejackets approved for Victorian Competitors (refer SLSA IRB Gear and Equipment Regulations), Level 50S lifejackets are not approved for SLSA lifesaving operations or for IRB competition.
- All Lifejackets are to be presented for scrutineering prior to use in competition.



EVENT CONDITIONS

COMPETITION BRIEFINGS

Team Manager Briefing

A mandatory briefing for State and Club Team Managers and key Officials will be conducted on Wednesday 21 July 2021 at 4:00pm for U23's, Masters, Interstates and Open Championships Online. Clubs should have a maximum of four (4) personnel to attend the Team Managers Briefing.

Officials Briefing

The mandatory Officials Briefing (Scrutineering) will be on Wednesday 21 July 2021 at 5:00pm. All officials will also be briefed on Thursday morning prior to competition beginning on beach.

COMPETITION RULES

The general competitive conditions as detailed in the current edition of SLSA Surf Sports Manual, and in particular, Section 3.3 Inflatable Rescue Boat (IRB) Competition_and any other subsequent circulars bulletins shall apply to the conduct of these events except where amended by this circular.

All clubs and competitor must be aware of updated competition rules as released October 2020. For ease of viewing updated rules can be found in the following extract of section 3 of 26th edition SSM.

Attention will be paid to competitor's compliance to eligibility and pre-requisites for IRB competition, coaching history and patrol obligations as described in the above manuals, rules, and documents.

MIXED IRB RELAY RACE

The Mixed IRB Relay Race shall be conducted as per SSM Section 3.3.4.5 except that two legs of the race must be completed by a male crew and two must be completed by a female crew (driver + crew person). It is up to each team to decide which leg is completed by what crew.

No one driver, crew or patient is permitted to complete more than one leg of the event.

OPENING CEREMONY

On Friday, 23 July 2021 at 7.00am an Opening Ceremony will be conducted. Flag bearers from each State and Club teams are required to march into the arena as directed and assemble for the Opening Ceremony. Consideration will be given to allow competitors in the first events adequate time to change into their competition apparel.

PROTESTS & APPEALS

A protest against a competitor or a team or against a decision of an Official must be lodged verbally with the Competition Liaison Officer or Championship Referee/Deputy within **5 minutes** of the completion of the event or the announcement of the result of an event.

A written protest must then be lodged with the Competition Liaison Officer or Championship Referee within 15 minutes of the verbal protest being lodged. Protest forms can be obtained from the Competition Liaison Officer. The result of an event, if not already announced, will be withheld until the protest and any subsequent appeal is decided. The Competition Appeals Committee will deal with all protests referred to it by the Referee in terms of Section 14 of the current edition of the Surf Sports Manual.



Team Managers are reminded that both the Championship Referee and the Appeals Committee will not entertain frivolous appeals, the decision for a disqualification will go through the Officials, Judge in boat and the Chief Judges before being posted so unless explicit evidence to that contrary will be classed as frivolous and dismissed by the Championship Referee. In this regard, please note that SSM (Clause 14.3.3b) states:

"Where the Referee or the Area Referee or the Sectional Referee considers (in their absolute discretion) that a **protest is frivolous**, or not of a serious nature, they may choose not to accept the protest."

Please also note that the Team Manager retains the right (under SSM Clause 14.3.3b) to appeal the matter but the Appeals Committee will also consider whether the matter is frivolous in assessing the grounds for appeal.

An appeals fee of \$150.00 (incl. GST) must accompany all protest appeals when submitted to the Appeals Committee for adjudication. If an appeal is upheld the fee shall be returned forthwith. The decision of the Competition Appeals Committee is final and there is no right of appeal against that decision.

More information pertaining to protests and appeals can be found in Section 14 'Protests, Appeals and Discipline' of the current edition of the Surf Sports Manual.

INTERSTATES DRAWS AND BALLOTS

Tube, Rescue and Mass Interstate events will be conducted as semi-finals. Teams and Relay events shall be conducted as finals unless otherwise advised by the Championship Referee.

Prior to the event SLSA will undertake a random draw for beach positions for the first event to be conducted. Beach positions for the second and subsequent events shall be determined by a 'rolling draw' format whereby all teams shall move sideways one beach position for each event conducted in the area i.e. if all States/Territories enter the Interstate IRB Championships, after the first event the State drawn in position 1 will move to position 2, 2 to 3, 3 to 4, 4 to 5, 5 to 6, 6 to 7 and the State drawn in position 7 moves to position 1. Should a State not compete in an event, the lane shall be vacant for the event.

The Championship Referee or their delegate will undertake any other ballots required on the beach on the day of the competition.

INTERSTATE POINTSCORE

All events conducted shall be of equal points and the State/Territory with the highest aggregate of points at the conclusion of the competition shall be declared the winner in each of the point score categories. The State/Territory with the highest aggregate of points at the conclusion of the Championships shall be declared the winner.

Point score points shall be allocated on a 7, 6, 5, 4, 3, 2, 1, basis for the positions $1^{st} - 7^{th}$ for each event contested. Nil points will be earned in the case of disqualification.

Where a dead heat occurs in the final of an event the States/Territories involved will share the placing and placing points relative to the finish placing. The next State/Territory to finish will receive the relative placing and placing points based on the number of individuals/teams finishing ahead of



them. For example: if two individuals/teams finish equal 1st both individuals/teams shall receive 7 points each. The next placing individual/team shall be awarded 3rd place and 5 points.

If, when the Championships have concluded there is a tied pointscore, the State/Territory with the most 1st placings will be declared the winner. Failing this, the State/Territory with the most 2nd places to 6th places respectively will be taken into account to determine a winner. If, after this procedure there is no single winner, then the pointscore will be declared a tie and dual trophies will be presented.

States may be offered the opportunity for development teams to participate in Interstate Competition in the end competition lanes if available. Any development teams are not eligible for placings, points or medals.

CLUB POINTSCORE

All events conducted shall be of equal points and the Club with the highest aggregate of points at the conclusion of the competition shall be declared the winner in each of the point score categories. The Club with the highest aggregate of points at the conclusion of the Championships shall be declared the winner.

Point score points shall be allocated on a 6, 5, 4, 3, 2, 1, basis for the positions $1^{st} - 6^{th}$ for each event contested. Nil points will be earned in the case of disqualification.

Where a dead heat occurs in the final of an event the Clubs involved will share the placing and placing points relative to the finish placing. The next Club to finish will receive the relative placing and placing points based on the number of individuals/teams finishing ahead of them. For example: if two individuals/teams finish equal 1St both individuals/teams shall receive 6 points each. The next placing individual/team shall be awarded 3rd place and 4 points.

If, when the Championships have concluded there is a tied pointscore, the Club with the most 1st placings will be declared the winner. Failing this, the Club with the most 2nd places to 6th places respectively will be taken into account to determine a winner. If, after this procedure there is no single winner, then the point score will be declared a tie and dual trophies will be presented.

Note: International clubs (and/or non SLSA affiliated clubs) are not eligible to earn points towards Australian Champion Club. Hence, any placing's achieved by non SLSA clubs will not be counted towards the overall point score and the points will be allocated in finals to the first 6 Australian Club place getters.

CODE OF CONDUCT

SLSA expects that all members involved in competition will co-operate to ensure a positive public image and to participate in a spirit of goodwill and sportsmanship.

The SLSA code of conduct is contained in the current edition of the SLSA Surf Sports Manual and any subsequent Bulletins. Any incidents or behavior likely to cause embarrassment or damage to the reputation and/or image of lifesaving competition will be managed as prescribed in the current edition of SLSA's Rules, Surf Sports Manual and any subsequent bulletins.



THEFT

Any person/s found stealing signage or any equipment owned by Surf Life Saving Australia or the hosting authority may be immediately reported to police and that person/s be brought before the SLSA Judiciary.

Please note that automatic disqualification of the team from the Championship will occur if any member is found guilty of theft.

SLSA ANTI-DOPING POLICY

- Surf Life Saving Australia supports the Australian Government, the Australian Sports Commission, the Australian Olympic Committee, and Sports Integrity Australia (SIA) in their efforts to eradicate the use of drugs in sport. SLSA has published an anti-doping policy, which will be adhered to for this event.
- Please be aware that random drug testing could take place during the Interstate and Australian IRB Championships 2021.
- It is highly recommended each Club team member (including management and staff) complete the SIA online e-learning program (Level 1) to ensure all personnel are aware of contemporary issues pertaining to anti-doping. The link to access this e-learning program is: https://elearning.sportintegrity.gov.au/ Further to this, it is highly recommended that each team, under the direction of the management, undergo at least one anti-doping education and awareness activity as a group.
- It is recommended each Club team member (including management and staff) utilise the SIA Check Your Substances reference site, or phone 1300 027 232.

MEDIA STATEMENTS

States/Territories & Clubs shall be permitted to promote the event and or their Club team within their own State (subject to SLSA approval). However, no Competitor, Team Manager, Official or spokesperson for a State shall make media statements that could bring the Australian & Interstate IRB Championships 2021, its sponsor, or Officials into controversy. Such statements shall be deemed to be a breach of SLSA discipline and may be dealt with accordingly.

Complaints regarding the organisation of the Championship, or any other matters, should be directed through the appropriate SLSA channels, and will be dealt with by the responsible section, or officers. Such official complaints will be acknowledged.

SPONSORSHIP

As detailed in the SLSA Sponsorship Policy teams may be asked to wear sponsors apparel during the presentation of medals and trophies. Apart from any SLSA sponsorship no items giving commercial identification may be worn during the official Presentation Ceremony.

In the event of clubs/individuals having conflicting sponsorship with an event sponsor, the association sponsorship policy must be adhered to.

Teams when entering the marshalling arena and competing must be 'clean' in competition gear with no sponsor's identification unless the Club also has the event naming rights sponsor as its sponsor. Should the event naming rights sponsor competition apparel for the event teams will be required to wear the event naming rights sponsor's competition apparel or in the event of conflict with a Club team sponsor, compete in SLSA branded apparel. If no such apparel is provided teams are to compete in SLSA branded apparel.



At the conclusion of events, place getters may be offered items of apparel identified with the event sponsor. It may be possible that TV interviews will be undertaken with prominent competitors, and in such cases, they may be asked to wear one of the official sponsor T-shirts and/or caps. Further, competitors may be required to carry the event sponsor's logos on craft, boats and equipment. Where physically possible, no existing signage will be covered. Those craft with rival sponsors to the event sponsor will not be required to display the event sponsors signage and/or to cover the rival sponsor's signage.

TEAM APP

Aussies 2021 will be using the 'Team App' smart phone application to send out updates and notifications to competitors. Download 'Team App' from your App Store or Google Play. Once you have downloaded the app and created a user login, search for 'IRB Championships 2021' in the search bar at the top of the screen and click on the event to join.
