	<p>Officials working with entry level participants in a club surf sport environment (recreationally or competitively).</p> <p>Core Officials will be able to officiate at any carnival including state champs where up to and including under 14 years age categories are conducted. Core Officials will be supervised by a Technical Official or above. There are four duties that they can carry out: Marshall, Recording Judge, Timekeeping Judge and Finish Judge.</p>	<p>Officials who choose to fulfil specific officiating role/s and who work with participants who are actively competing in a club / branch / state surf sport competition environment. Officiating roles may include:</p> <ul style="list-style-type: none"> • Marshall / Check-Marshall • Starter / Check-starter • Recorder • Timekeeper • Finish Judge 	<p>Officials who choose to fulfil specific senior officiating roles and who work with athletes competing in state / national surf sport competition environments. Officiating roles may include:</p> <ul style="list-style-type: none"> • Chief judge • Referee • Area referee • Sectional referee • Course supervisor <p>The Senior Official is also mentor to other core and technical officials and can facilitate NOAS training workshops in their nominated roles.</p>
Branch Endorsement	A declaration by a branch officer that the person submitting the reaccreditation is endorsed by the branch to officiate.		
State Endorsement	A declaration by a state officer that the person submitting the reaccreditation is endorsed by the club to officiate.		
National Endorsement			A declaration by a SLSA representative that the person submitting the reaccreditation is endorsed by the club to officiate.
Evidence	100 points must be achieved prior to the 31 st December in the year the license expires to maintain status as a licensed surf sport official. Please make sure a copy of your log book is attached.
