- Hold a current Official accreditation

When Official appointments have been finalised, all Officials who nominated will be notified by an Official Appointment Memo. Appointments will also be shared on the event page.

ADDITIONAL INFORMATION

- All Officials should ensure that they are physically capable to carry out their important functions over the days of the Championships, and are encouraged to undertake a medical check prior to the Championships.
- All appointed Officials are encouraged to attend the Official's Briefings. All times and locations will be outlined in the Officials Appointment Memo.
- Appointed Officials are responsible for all costs associated with travel and accommodation for the Championships.
- Officials are expected to wear a SLSNSW Country or State Championships Officials shirt
- While every effort is made to appoint you to your preferred position, it is not always possible to do so. All appointments will be posted on the event page.
