<b>Subject: NSW Rural Fire Service and Surf Life Saving NSW Coastal Helicopter Trial Expression of Interest</b>

## Background

In early 2023 the NSW Rural Fire Service (NSWRFS) and Surf Life Saving NSW (SLSNSW) undertook a controlled trial of coastal surveillance flights utilising an NSW RFS helicopter along the North Coast. These flights covered the coastline from Red Rock to South West Rocks and provided an additional layer of surveillance on weekends and public holidays to support volunteer and lifeguard patrols along this busy stretch of coastline.

SLSNSW members on these flights provided their expertise in coastal surveillance whilst also collecting statistics of beach population numbers and other incident data during the flights. The success of the trial will see the program implemented once again for the 2024/25 season. The program will run for approximately 18-20 days across a 6-7 week period in late February and March 2025.

## Expression of Interest Selection Criteria

SLSNSW are now seeking expressions of interest from those members who would like to be considered to participate in the helicopter coastal surveillance program on the North Coast at Coffs Harbour.

Members must be current financial members and must hold and be proficient in the following awards as a minimum:

- Bronze Medallion
- Silver Medallion Aquatic Rescue
- Provide First Aid
- Advanced Resuscitation Techniques

Members selected will also need to be able to attend training with the NSWRFS in late January/early February 2025 to undertake two short training courses. These courses are Work Safely Around Aircraft and Helicopter Underwater Escape Training (HUET).

The program will run from Coffs Harbour and whilst the EOI is open to all SLSNSW members those members selected will be required to transport themselves to and from Coffs Harbour to undertake their designated shifts at their own cost. SLSNSW will not be covering any travel expenditure during the trial period.
