Nominations should include details of the preferred roles you would like to fulfill, with two (2) preferences listed in order of priority. While every effort is made to appoint you to your preferred position, it is not always possible to do so.

SLSNSW reserves the right, in its absolute discretion to:

- A) Not appoint an Official to any position whether an Official has nominated or not;
- B) Remove and Official from any position at any time (whether before or during an SLS event).

SLSNSW is not obligated to provide reasons where it acts under this clause.

#### **Officials Requirements**

Surf Life Saving NSW is looking for accredited Officials who meet the following requirements:

- Be a current financial member of a club for 2024/25 season.
- Hold a **minimum** of a current Technical Official accreditation.

When Official appointments have been finalised, all Officials who nominated will be notified by an Appointment Memo.

#### **Officials Quota**

An Officials Quota system may be applied if there are insufficient official nominations based on the number of crews entered in each respective Championship.

## **Additional Information**

• All Officials should ensure that they are physically capable of performing their required duties over the days of the Championships and are encouraged to undertake a medical check prior to the Championships.

- Nominating does not guarantee an appointment.
- All appointed Officials are encouraged to attend the Officials Briefings. All times and locations will be outlined in the Appointment Memo.
- Appointed Officials are responsible for all costs associated with travel and accommodation for the Championships.
- Officials who nominate, and are not appointed, will be placed into the 'Officials Pool' and positions may be allocated if they become available.
- While every effort is made to appoint you to your preferred position, it is not always possible to do so.
