### INFORMATION

SLSNSW is seeking nominations for Team Management roles to assist the 2026 and 2027 NSW Surf Boat Interstate Team. The 2026 Surf Boat Interstate Championships will be held on Friday 13 February 2026 at Wanda SLSC.

### THE ROLES AVAILABLE FOR THE NSW INTERSTATE TEAM ARE:

- Team Manager (x1) – 2-year appointment
- Assistant Team Manager (x1) – 2-year appointment

### REQUIREMENTS OF TEAM MANAGEMENT

Desirable experience and attributes for the above Team Management roles include but not limited to:

- Provide logistical support, and attend all development/high performance clinics and team training
- Monitor / collate results at selection carnivals
- Financial SLSC member, endorsed by club & branch.
- Comprehensive knowledge of Surf Boat competitions and rules.
- Previous touring experience.

- Current First Aid certificate.
- Organise and attend all team training sessions.
- Demonstrated ability to think innovatively and strategically.
- Highly motivated and passionate about enhancing the success of NSW Athletes.
- Compile a report within three weeks of completing competition (Team Manager).

## HOW TO NOMINATE

- Read the Entry Circular (when available).
- All nominating members are asked to familiarise themselves with the [SLSNSW Selection Policy](#). All Team Management will be required to comply with the guidelines and expectations set out in this document.
- Complete the [nomination form](#) by 19 October 2025.
- All nominees must be current financial members and hold any relevant awards. All nominations must be endorsed by both Club and Branch representatives prior to selection, please contact your Club and Branch to acquire letters of endorsement – Any nomination that fails to meet these requirements will not be accepted.

The appointment period will commence from the date of appointment and will expire 28 days after the 2027 Surf Boat Interstate Championships.

## COSTS

All costs (including travel & accommodation) are the responsibility of individuals. SLSNSW will provide a team uniform.

## SLSA MATCH FIXING & ANTI-DOPING POLICY
