Subject:	2026 Sharkskin NSW IRB Premiership – Round 3 Update

On 20 April 2026, a further meeting of the select committee was convened, comprising three Athlete Representatives (with the fourth providing written input), Referees, and other key stakeholders. The purpose of the meeting was to consider options for the delivery of Round 3 of the IRB Premiership.

At the initial meeting, potential locations within the Hunter, Central Coast, and Sydney Northern Beaches Branches were discussed. Given that other rounds are already scheduled within the Hunter and Central Coast regions, members of the committee were tasked with identifying suitable venues, including contingency options, within the Sydney Northern Beaches Branch.

It is pleasing to report that several clubs expressed interest in hosting the event. However, due to a range of constraints, a number of these venues were ultimately deemed unsuitable or unavailable.

Following further assessment, the subgroup recommended Queenscliff SLSC as the preferred venue, with Freshwater SLSC identified as the backup location after consideration of alternative options.

Queenscliff SLSC demonstrated strong commitment to hosting the event, including rescheduling their presentation evening to accommodate Round 3.
